Councilman Lahullier stated that the yearend report from the Fire Marshall's office was included in the packets.

Councilman Lahullier stated that he received two quotes from Industrial Electric - \$960 for baseboard heating and \$1,264 for a heater. He is looking to get additional quotes.

Councilman Lahullier requested an executive session for litigation and property acquisition. Councilman Stallone also requested an executive session.

ENGINEER'S REPORT – GLENN BECKMEYER

Engineer Beckmeyer submitted Application #5 from Smith Sondy in the amount of \$178,862.90 for the 2013 Roadway Improvement Program:

Councilman Ravettine asked if we require maintenance bonds on bid projects. Engineer Beckmeyer stated yes. A brief discussion was held on the requirements.

Mayor Cassella stated that the landscaping bid has expired and asked for a motion to authorize the Engineer to go out to bid. He suggests that it go out to bid soon so it can be awarded before the spring. It was asked that any comments or additions be given to Engineer Beckmeyer before the bid package is complete.

ATTORNEY'S REPORT - GERALD SALERNO

Attorney Salerno stated that his report will be given in Executive Session as there are legal issues.

DPW/RECYCLING/VEHICLE MAINT - COUNCILMAN RAVETTINE

Councilman Ravettine requested an Executive Session for personnel.

Councilman Ravettine stated that there is a large tree on Orchard Street that the DPW does not have the ability to get the trunk down. They are currently getting prices to have it lowered. He made a motion to bring in a company at a price not to exceed \$500.00:

Councilman Ravettine stated that the cost of a new Toro would be approximately \$28,000. Rather than purchase a new one he has received a quote in the amount of \$4,685.54 to send out the one we currently own and restore it. Hopefully we can get another ten years out of it. Councilman Sorbera stated that he also met with the Construction Official regarding the Building Department.

A meeting will be set up with Chief Minda and Francis Joseph regarding the LEPC.
